This form must be signed to complete the registration process. Please read the policies and procedures of the After Care Program and then sign your agreement below:

- I understand the After Care Program is open according to the official school calendar of Prince of Peace Catholic School and is closed during vacations, school holidays, teacher workdays, I understand that I am responsible for payment of monthly fees to the POP After Care Program. After Care charges will be posted to your FACTS Mgt. account monthly. Enrollment may be terminated if accounts are past due. I understand that a late pick-up fee of \$1.00 per minute will be charged after 6:00 pm for the first 15 minutes. In addition, \$2.00 will be charged for each additional five minutes thereafter. I also understand that once I have accumulated five late pick-ups my services may be terminated from the program at the discretion of the Director, Principal, and Pastor. I will update my child's emergency and other pertinent information if changes occur. It is my responsibility to come in and sign my child out when leaving the After Care Program. I understand that
